	 The Defendant has updated the price display on Reservations.com to show the full price of the reservation at the first step of the reservation process, without any admission to its liability. 	
	 The class members' lawyers will be receiving legal fees authorized by the Court representing 25% of the lump sum, plus taxes and disbursements.
